**Statement of Faith**

- **WE BELIEVE** in one sovereign God, eternally existing in three persons: the everlasting Father, His only begotten Son, Jesus Christ our Lord, and the Holy Spirit, the giver of life; and we believe that God created the Heavens and the earth out of nothing by His spoken word, and for His own glory.
- **WE BELIEVE** that God has revealed Himself and His truth in the created order, in the Scriptures, and supremely in Jesus Christ; and that the Scriptures of the Old and New Testaments are verbally inspired by God and inerrant in the original writing, so that they are fully trustworthy and of supreme and final authority in all they say.
- **WE BELIEVE** that Jesus Christ was begotten by the Holy Spirit, born of the Virgin Mary, and was true God and true man, existing in one person and without sin; and we believe in the resurrection of the crucified body of our Lord, in His ascension into heaven, and in His present life there for us as Lord of all, High Priest, and Advocate.
- **WE BELIEVE** that God directly created Adam and Eve, the historical parents of the entire human race; and that they were created in His own image, distinct from all other living creatures, and in a state of original righteousness.
- **WE BELIEVE** that our first parents sinned by rebelling against God's revealed will and thereby incurred both physical and spiritual death, and that as a result all human beings are born with a sinful nature that leads them to sin in thought, word, and deed.
- **WE BELIEVE** in the existence of Satan, sin, and evil powers, and that all these have been defeated by God in the cross of Christ.
- **WE BELIEVE** that the Lord Jesus Christ died for our sins, according to the Scriptures, as a representative and substitutionary sacrifice, triumphing over all evil; and that all who believe in Him are justified by His shed blood and forgiven of all their sins.
- **WE BELIEVE** that all who receive the Lord Jesus Christ by faith are born again of the Holy Spirit and thereby become children of God and are enabled to offer spiritual worship acceptable to God.
- **WE BELIEVE** that the Holy Spirit indwells and gives life to believers, enables them to understand the Scriptures, empowers them for godly living, and equips them for service and witness.
- **WE BELIEVE** that the one, holy, universal Church is the body of Christ and is composed of the communities of Christ's people. The task of Christ's people in this world is to be God's redeemed community, embodying His love by worshipping God with confession, prayer, and praise; by proclaiming the gospel of God's redemptive love through our Lord Jesus Christ to the ends of the earth by word and deed; by caring for all of God's creation and actively seeking the good of everyone, especially the poor and needy.
- **WE BELIEVE** in the blessed hope that Jesus Christ will soon return to this earth, personally, visibly, and unexpectedly, in power and great glory, to gather His elect, to raise the dead, to judge the nations, and to bring His Kingdom to fulfillment.
- **WE BELIEVE** in the bodily resurrection of the just and unjust, the everlasting punishment of the lost, and the everlasting blessedness of the saved.

**Philosophy of Education**

The authority of the Mid Vermont Christian School Association is the Scriptures of the Old and New Testaments. The standard text for the School is the New King James Version. Organizationally, the Association is not an ecclesiastical body nor is it subject to any ecclesiastical organization. The government of Mid Vermont Christian School is autonomous. We believe that the primary responsibility for the education of children lies with the parents and that the School should be an extension of the Christian home. In every way the School should serve to underscore, continue and augment the biblical teachings of the home. This necessitates an active role on the part of the parents in the School.

We believe:

- **The Bible:** By His holy Word, God reveals Himself; renews man's understanding of God, of mankind and of the world; directs man in all his relationships and activities; and therefore guides His people in the education of their children.
- **Creation:** In education children must learn that the world and man's calling in it can rightly be understood only in relation to the triune God, Who by His creation, restoration and governance directs all things to the coming of His kingdom and the glorification of His name.
- **Sin:** Because man's sin (which brought upon all mankind the curse of God, including death, and alienated him from his creator, his neighbors and the world) distorts his view of the true meaning and purpose of life, it misdirects human culture and corrupts the education of youth.
- **Jesus Christ:** Through our Savior, Jesus Christ, there is renewal of our minds and educational endeavors, because He is the Redeemer, the Light and the Way for our human life in all its range and variety. Only through Him and the work of His Spirit are we guided in the truth and recommitted to our original calling.
- **Community:** Because God's covenant does not only embrace parents and their children, but also the whole Christian community to which they belong, and because Christian Education contributes directly to the advancement of God's kingdom, it is not only the obligation of parents but also of the Christian community to establish and maintain Christian schools, and to pray for, work for, and give generously to their support.
- **Educational Freedom:** Christian schools, organized and administered in accordance with legitimate standards and provisions for day school, should be fully recognized in society as free to function according to their principles.

Education that is truly Christian is approached with "the mind of Christ." We are desirous, therefore, that Christian Education be in complete accordance with the teachings of Scripture and that children will embrace God's perspective on life and the circumstances, situations, views, philosophies, mores, moralities, histories, etc. of society and the world at large.

We rigorously seek academic excellence, so that all students may be well equipped to examine and process facts, react or initiate action when necessary, and live a productive God-honoring life. We are hopeful that in this way our students will highly esteem godliness, and be a more effective ambassador of the Gospel of Salvation.

Teachers should be apt to teach and be governed by the Holy Spirit, so that they may have God's sensitivity to the particular child and his unique personality. Whereas children have not all come under the government of Christ in their lives, there is a need for clear guidelines, authority, and discipline. As the teacher works with the parent in this capacity, the ultimate goal of education for the particular child should be voluntary submission to the government of Christ. In this way the particular child can excel to the highest level in accordance with all that we have stated above.
